Alchemy expects its employees and individuals working on its behalf to conduct their activities in an environmentally responsible manner. Alchemy operates across the world and seeks to employ a workforce that reflects the diversity of the communities in which it works. However, because of client requirements or non-availability of appropriately qualified or experienced local people, it is often driven to source staff from beyond local or even national markets. The nature of the staff that we need, the supply of that staff from the labour market and our determination to recruit the best staff available will therefore ultimately determine the composition of our workforce.

Information security



Commitment

Information is a key asset to our clients and its correct handling is vital to the delivery of our services and to the integrity of Alchemy.

Application of the system on specific projects is the responsibility of the Project Director.
